The ICC functions as a statutory mechanism to promote gender equity and ensure a safe, respectful, and inclusive environment for students, faculty, and staff.

Objectives of ICC

- To uphold the constitutional right to gender equality and provide a grievance redressal system for gender-based concerns.
- To create awareness among stakeholders about gender sensitivity, legal rights, and respectful conduct.
- To act as a recommending body to promote institutional practices aligned with gender justice.

Key Functions

• Complaint Redressal

ICC receives complaints related to discrimination, harassment, or unfair treatment based on gender. Complaints can be submitted through prescribed online or offline formats.

• Investigation & Inquiry

The committee conducts a fair, neutral, and time-bound inquiry into the complaints submitted. Both the complainant and the respondent are heard with equal respect and confidentiality.

• Institutional Sensitization

The ICC organizes regular gender sensitization seminars, workshops, and policy awareness programs to instill respect and accountability within the institutional culture.

• Policy Evaluation & Recommendations

The committee periodically reviews SGI's internal policies regarding discipline, safety, and equality. Suggestions are submitted to institutional heads for policy revision and action.
